Southern York County EMS

Richard Brooks representing SYCEMS informed board meetings will be held in July and September. Total calls for the month were 142, with 48 mutual aid received and 25 mutual aid given, Peach Bottom Townships share was 36. Concerning recruitment, 2 people are in reciprocity and 1 paramedic will be going part time. Fundraisers have been and continue to be held to raise funds for the service.

Subdivisions & Land Development Plans

Calpine – Land Development Plan

Craig Wilson representing Calpine informed that a page from the approved land development plan has been adjusted and provided in reference to an addition to be built on an existing pad which will house a temporary control and server room. This addition does not change compliance with setbacks or any other requirements.

Lot 1, containing Power Block 1 with 23+/- acres and lot 2 containing Power Block 2 with 23+/- acres. Then Lot 2 will be merged with Map BQ Parcel 11 & AQ Parcel 13 creating a 66+/- acre lot containing Power Block 2 of the York Energy Center.
