Ed Grimmel requested status of Greenwood Forest project, road inspection report and asked when the development could be accepted. Supervisors explained that numerous items remain incomplete including stormwater management, drainage easements, and proper plan updates reflecting relocated driveways. The Township Engineer will issue a list of outstanding deficiencies. Supervisors advised the developer to work with his own engineer to complete corrections prior to any adoption consideration.
